Dear Ms. Bayó:

On October 21, 2002, City Gas Company of Florida filed in this docket a "Petition for Approval of Tariff Modification and Rule Waivers to Implement Pilot Flat Rate Billing Program for NUI City Gas Company of Florida."

By this letter, City Gas hereby waives the provisions of Section 366.06(3), Florida Statutes, which provide that a revised rate schedule may go into effect unless suspended by the Commission within 60 days of filing. City Gas will treat the filing as though the Commission had entered a timely order suspending the tariff for 8 months from the date of filing. City Gas, however, is not waiving the 8-month and 12-month provisions of Section. 366.06(3).
