In its July 19, 2002 Order in the above-referenced docket, the Georgia Public Service Commission ("Commission") adopted a notification process by which BellSouth Telecommunications, Inc. ("BellSouth") is required to provide notice and obtain Commission approval of changes to the method by which BellSouth's performance data is calculated. Under this Commission-approved process, BellSouth must provide written notice on the first business day of each month and conduct an industry conference call, after which parties have ten business days to file written comments with the Commission concerning any of BellSouth's proposed changes.


Consistent with the Commission's Order, BellSouth has established a schedule for the industry conference calls that will be conducted during the year of 2003. The conference calls will be held on January 8, February 7, March 7, April 7, May 7, June 6, July 8, August 7, September 8, October 7, November 7, and December 5, 2003, and will be conducted from 2:00 p.m. to 5:00 p.m. (ET). The same conference bridge number will be used for each call, which is 205-970-3745, access code 6527. BellSouth has taken the liberty of preparing a schedule outlining these calls as well as the deadlines for BellSouth's filing written notification of proposed data changes and for interested parties' filing comments with the Commission. A copy of the 2003 schedule is enclosed.
