On November 2, 2002, XO Communications, Inc. ("XO") filed the above-captioned application regarding its reorganization pursuant to the Stand-Alone Plan to emerge from bankruptcy ("Application"). It was noted in the Application that it was anticipated that the Bankruptcy Court would consider the confirmation of the Stand-Alone Plan in mid-November 2002. This letter is to advise the Commission that on November 15, 2002, the Bankruptcy Court confirmed the Stand-Alone Plan.¹ Thus, the parties expect to implement the Stand-Alone Plan as soon as possible, and the parties again request expedited action on the Application so that XO can emerge from bankruptcy expeditiously.


