**NOTICE OF CHANGED DATES AND DEADLINES  
WITH RESPECT TO DEBTORS' PROPOSED PLAN OF REORGANIZATION**

TO ALL CREDITORS AND OTHER PARTIES IN INTEREST OF (a) Startec Global Communications Corporation, (b) Startec Global Operating Company, or (c) Startec Global Licensing Company (collectively, the "Debtors") – each of the Debtors being a Delaware corporation with its principal place of business at 1151 Seven Locks Road, Potomac, Maryland 20854.

PLEASE TAKE NOTICE, that on September 11, 2002, the Bankruptcy Court entered an order (docket no. 363, the "Solicitation Order"), among other things: (a) approving the Disclosure Statement for Debtors' Joint Plan of Reorganization, as Amended, dated September 11, 2002; (b) establishing procedures for creditors to vote on the Debtors' Joint Plan of Reorganization, as Amended, dated September 11, 2002 (the "Plan"); and (c) scheduling a hearing to consider confirmation of the Plan. You have previously been mailed a copy of the Solicitation Order and/or a notice summarizing the Solicitation Order.

PLEASE TAKE FURTHER NOTICE, that the Bankruptcy Court has issued an order, dated November 21, 2002, directing the Debtors to send this Notice informing you of the following changes to certain dates and deadlines established in the Solicitation Order; all other provisions of the Solicitation Order are unaltered:

- I. **January 13, 2003 at 4:00 p.m. Greenbelt, Maryland time** is the deadline for filing, in accordance with the Solicitation Order, any objections to confirmation of the Plan or to the proposed assumptions and rejections of executory contracts and unexpired leases pursuant to the Plan;
- II. **January 17, 2003 at 4:00 p.m. El Segundo, California time** is the deadline by which all ballots casting votes to accept or reject the Plan must be delivered to the balloting agent in accordance with the Solicitation Order (any creditor that has already submitted a ballot in accordance with the Solicitation Order need not submit a new or additional ballot by such extended deadline unless such creditor wishes to change its vote with respect to the Plan);
- III. A hearing to consider confirmation of the Plan and on the proposed assumptions and rejections of executory contracts and unexpired leases pursuant to the Plan is scheduled to commence at the Bankruptcy Court in Greenbelt, Maryland on **February 3, 2003 at 10:00 a.m.** (the "Confirmation Hearing"); and
- IV. **January 22, 2003 at 4:00 p.m. Greenbelt, Maryland time** is the deadline for the filing and delivery, in accordance with paragraph 34 of the Solicitation Order, of exhibits proposed to be used at the Confirmation Hearing, and **January 29, 2003 at 4:00 p.m. Greenbelt, Maryland time** is the deadline for the filing and delivery, in accordance with paragraph 34 of the Solicitation Order, of objections to such exhibits.
