

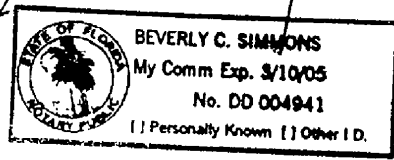

FOR AN EXTENSION OF WATER SERVICE AREA

Notice is hereby given on this 16th day of November, 2002, pursuant to Section 367.045(2), Florida Statutes,

of the application of Aquasource Utility, Inc., of its intent to apply to the Florida Public Service Commission for an extension of its 48 Estates System's service area to provide water service to the property in Lake County, Florida, more particularly described as follows:

48 Estates Service Area to be added:

Beginning at the Southwest corner of Section 12, Township 19 South, Range 25 East, Lake County, run North 639 feet to the South boundary of Moore Street; thence East along Moore Street, 430 feet to the Northwest corner of Lot 16, Block C, Hilltop Subdivision, for a POINT OF BEGINNING.
