- 1. Provide a readable copy of contract. The copy of the Contract for Sale and Purchase of the stock of Colony Park Utilities, Inc., provided in the application for the transfer of majority organizational control is not legible. Please provide a more legible copy of the contract.
- 2. DEP Consent Order. According to the February 28, 2002, closing statement, the seller's closing costs included an escrow payment for a DEP consent order. If the consent order pertains to the Colony Park Utilities, Inc., please provide information regarding the consent order.
- 3. Other Owned Water and/or Wastewater Utilities. The application stated that there were two other utilities owned by the buyer located in Auborndale and Hobe Sound. The Public Service Commission has jurisdiction within these two areas, but no information could be found regarding these two utilities without the actual utility name or certificate number. You were previously asked to provide additional information as to whether these systems are exempt from Commission regulation; however, your response did not address the issue. Please provide, by utility, the capacity of the water and/or wastewater system, the method of billing, and how long the utility has been in existence.
