Please be advised that FreedomStarr Communications, Inc. ("FreedomStarr" or "Company"), a competitive telecommunications provider certified to provide resold interexchange services in Florida, will no longer use the fictitious name USPhone in Florida. FreedomStarr has made the requisite Department of State filing as evidenced by **Attachment A**.

FreedomStarr also intends to do business in Florida under an additional fictitious name, QueerFone. The Company has already registered the name QueerFone with the Florida Department of State, as evidenced by **Attachment B**.

FreedomStarr will continue to use its other fictitious names, which are already registered with the Department of State and with the Commission: iPhonebill.com, AmericanFone, and Planet Earth Communications. With the addition of QueerFone, FreedomStarr will continue to use a total of four (4) fictitious names in Florida. The Company is in the process of preparing tariff revisions, which will include the fictitious name changes, and will file the new tariff within the next couple of weeks.

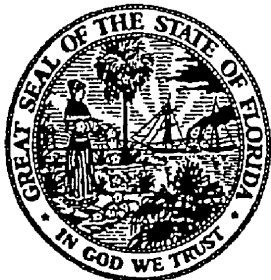
