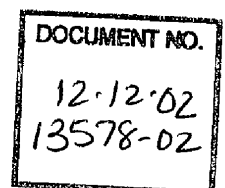

RE: Request for Permission from Comptroller's Office to Write-Off the RAFs for the years 2000, 2001, and 2002 for Net-tel Corporation (TJ015 and TX207).

On August 16, 2002, Docket No. 020894-TP was established to address Net-tel Corporation's (Net-tel) request for cancellation of its Alternative Local Exchange Telecommunications (ALEC) certificate and Interexchange Telecommunications (IXC) certificate due to Chapter 11 bankruptcy. By Order No. PSC-02-1539-PAA-TP, issued on November 12, 2002, the Commission approved the cancellation of Net-tel's ALEC Certificate No. 5646 and IXC Certificate No. 5268. The Commission further ordered that the outstanding Regulatory Assessment Fees not be sent to the Comptroller's Office for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write-off the uncollectible amount.

Therefore, staff requests that Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Comptroller's Office to write-off the uncollectible RAFs, including penalty and interest, for the years 2000, 2001, and 2002 for Net-tel.
