Dear Ms. Bayo:

Please accept this letter as the request of TalkNow, Inc. ("TalkNow") to cancel its certificate to provide Interexchange Telecommunications Service ("IXC") in the state of Florida, effective immediately. Please be advised that TalkNow has never had, and currently has no, customers for any telecommunications services within Florida (retail or wholesale). This request for cancellation is based upon the determination by TalkNow that it no longer wishes to be a certificated provider in the State of Florida. In addition, enclosed please find a check in the amount of \$68 as payment of the regulatory assessment fees ("RAF") for the year 2001. The 2002 RAF fees will be paid prior to the due date of January 30, 2003. I have also enclosed the completed RAF return for the year 2001.
