MASTER INTERCONNECTION AND RESALE AGREEMENT

FOR THE STATE OF FLORIDA

BETWEEN

Burno Inc. dba Citywide Tel

and

Sprint – Florida, Incorporated

This Master Interconnection and Resale Agreement ("Agreement") between Burno Inc. dba Citywide Tel, a Florida CLEC ("CLEC") and Sprint - Florida, Incorporated, a Florida corporation ("Sprint"), herein collectively, "the Parties," is entered into and effective this 4th day of October 2002, for the State of Florida.

NOW THEREFORE, the Parties agree as follows:

The Parties agree that the Agreement between the Parties shall consist of the Master Interconnection and Resale Agreement for the State of Florida entered into by and between Sprint and 1-800-RECONEX, Inc., dated June 30, 2001 – June 29, 2003 ("Adopted Agreement"), amended as follows:

1. TERM

- 1.1. This Agreement shall be in force and become effective on the 4th day of October 2002, or the date of Commission approval, if required.

2. CONDITIONS

- 2.1 All services provided under this agreement will be consistent with the decisions of courts, the Federal Communications Commission, and any state Commission having jurisdiction over this agreement, including but not limited to the decisions of the 8th Circuit Court of Appeals and the United States Supreme Court.
- 2.2 This Agreement shall be amended accordingly to reflect the pricing, terms and conditions of each such Amended Rules relating to any of the provisions in this Agreement.

3. RATES

- 3.1 All rates provided under this agreement will include any subsequent amendments executed by Sprint and CLEC, as well as any rates based upon decisions of any court, federal or state commission having jurisdiction over this Agreement.

4. GENERAL

- 4.1. Other than as set forth above, the Adopted Agreement remains unchanged and in full force and effect. In the event of a conflict between the terms of the Adopted Agreement and this Agreement, this Agreement will control.

- 4.2. This Agreement, executed by authorized representatives of Sprint and CLEC, is made a part of and incorporates the terms and conditions of the Agreement and Adopted Agreement.
- 4.3. This Agreement supercedes all other Interconnection and/or Resale agreements between Sprint and CLEC, including the Master Resale Agreement between Sprint and Integra Paging, dated March 6, 1998.

- 5.1 Except as otherwise provided, all notices and other communication hereunder shall be deemed to have been duly given when made in writing and delivered in person or deposited in the United States mail, certified mail, postage paid, return receipt requested and addressed as follows:



6. PARTIES


