1. On December 6, 2002, BellSouth Telecommunications, Inc. filed a Petition for Expedited Review of NXX-X Code Denial for the Jacksonville Exchange (Beachwood), along with Attachments 1, 2 and 3. Attachments 1 and 3 contain information that is considered confidential and proprietary to BellSouth. 
4. Appended hereto as Attachment B are two copies of the requested documents with the confidential information deleted.


