Highvest Corporation ("Highvest"), and L.P. Utilities Corporation ("L.P."), by and through their undersigned attorneys and pursuant to Section 120.57, Florida Statutes, and Rule 28-106.201, Florida Administrative Code, file this Petition for Formal Administrative Hearing with regard to Commission Order No. PSC-02-1739-PAA-WS ("PAA Order"), and in support thereof states:

- 2. The name and address of the Petitioners, and how their substantial interests are affected are:
 - A. Highvest Corporation 100 Shoreline Drive Lake Placid, FL 33852-5022

Highvest's substantial interests are affected by the PAA Order in that it acquired the Utility systems in question in a mortgage foreclosure action on September 27, 2002. The PAA Order purports to require Highvest to make refunds of rates collected by the prior owner, The Woodlands of Lake Placid, L.P., and also reduces rates on a prospective basis, requiring Highvest to make refunds of rates collected during its ownership.

B. L. P. Utilities Corporation129 South Commerce AvenueSebring, FL 33870

L. P.'s substantial interests are affected in that it purchased the Utility system in question from Highvest Corporation in October 1, 2002,. Thus, the PAA Order would require it to make refunds of rates collected during its ownership, and also reduce current rates, both actions adversely affect L.P.

- 4. Petitioners received notice of the PAA Order on or about December 12, 2002, by U.S. Mail.
 - 5. The following are the disputed issues of material fact:
 - A. Whether either Petitioner may be held responsible to make refunds of rates collected by The Woodlands of Lake Placid, L.P.
 - B. The appropriate amount for office rent.
 - C. The imputation of CIAC.
 - D. Whether the underearnings in wastewater rates should have been used to offset the alleged overearnings in water rates.
 - E. The appropriate regression adjustment.
 - F. The appropriate amount of rate case expenses.
 - 6. A. The Woodlands of Lake Placid, L.P., and Highvest Corporation are separate

and distinctive legal entities, and none of the partners of The Woodlands of Lake Placid, L.P., hold any ownership interest in Highvest Corporation. There is no legal theory by which Highvest Corporation can be liable for the financial obligations of The Woodlands of Lake Placid, L.P.

- В. Office rent is a legitimate expense and should be included in rates.
- C. It is improper to impute CIAC in the amount imputed in the Order.
- D. The PSC policy is where the water customers and wastewater customers are substantially the same, any underearnings in one systems is used to offset any overearnings in the other. That policy should have been applied in the instant case.
- E. The estimated reduction in consumption as a result of converting from flat to metered rate is understated.
- F. Petitioners are entitled to reimbursement of reasonable rate case expenses.
- 7. The Statute and Rules relied upon by Petitioners are Sections 367.081 and 367.0816. Florida Statutes.
- 8. L.P. will establish an escrow account for purposes of securing a refund should one be ordered upon the Commission's final consideration of this matter.

WHEREFORE, Petitioners request the Commission hold a formal administrative hearing and to establish rates on a prospective basis that are fair, just and reasonable.
