

**NOTICE OF INTENT NOT TO CHARGE OR COLLECT  
PURCHASED GAS COST RECOVERY FACTOR**

Indiantown Gas Company, Inc. ("Company") hereby gives notice to the Florida Public Service Commission that it will not implement a purchased gas cost recovery charge for bills rendered after December 5, 2002. Pursuant to the Company's recently revised Natural Gas Tariff, Original Volume 2, approved by Commission Orders PSC-02-1666-PAA-GU and PSC-02-1829-CO-GU to be effective as of December 5, 2002, the Company is no longer authorized to collect a PGA charge. (The Company will address the remaining overage in its already-collected PGA charges by a filing that the Company expects to make no later than February 15, 2003.) Also, pursuant to Commission Orders PSC-02-1655-TRF-GU and PSC-02-1830-CO-GU, the Company is authorized, on a transitional basis, to exit the merchant function, and accordingly, no PGA charge is appropriate.
