

**VERIZON FLORIDA INC.'S MOTION FOR ORAL
ARGUMENT ON ITS MOTION FOR RECONSIDERATION
OF COMMISSION VOTE FOR PROCEDURAL IMPROPRIETY**

Today, Verizon Florida Inc. (Verizon) filed a Motion for Reconsideration of the Commission's vote on Issue 3 in this case at its December 17, 2002 agenda conference. As stated in that Motion, the Commission improperly held oral argument on Issue 3 at the agenda conference because of an erroneous interpretation of the governing rules in the Florida Administrative Code. Verizon requests oral argument on its Motion. Oral argument will help the Commission to more fully understand what rules apply, how they are properly interpreted in accordance with rules of statutory construction, and how the Commission can best correct the procedural impropriety described in Verizon's Motion.
