Re: Docket No. 021142-WU - Application for Amendment of Certificate No. 441-W to Extend Water Service Area for the 48 Estates System in Lake County by AquaSource.

Dear Mr. Friedman:

After reviewing the application in the above-referenced docket, the staff has identified the following deficiencies. Please correct and/or provide additional information as requested.

1. As required by Section 367.045(1)(a), Florida Statutes, and Rule 25-30.030, FAC, the utility must provide notice of the application and provide affidavits that the notice was given. The notice must be given to each customer of the system to be certificated. Paragraph 16 in the application, indicates that the proof of noticing will be late filed. Please provide an affidavit that the customers were noticed.

2. As required by Rule 25-30.036(3)(p), Florida Administrative Code, the utility must provide the applicant's current certificate for possible amendment. The certificate was not mentioned in the application.

A map was provided for the amendment of territory and it appears to correct. Another map and territory description was provided in Exhibit B-2 of the entire service area. However, we are not able to correlate Exhibit B-2 with the existing and proposed territory descriptions. Please superimpose the existing territory and the proposed territory on a map and label all bearings and distances necessary to provide a continuous description.

Please file an original and five copies of the requested information no later than January 31, 2003 with the Director, Division of Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, FL 32399. Only one copy of the map is required.
