On June 1, 2001, when copies of certain portions of staff's audit working papers obtained or prepared during the FPU Purchased Gas Adjustment audit for the year ended December 31, 2000, were delivered to FPU at the audit exit conference, the utility requested that these materials be temporary excepted from public access in accordance with the provisions of Rule 25-22.006(3)(a)(2), Florida Administrative Code (FAC). On June 21, 2001, staff filed document 07733-01, consisting of those specified portions of the staff audit working papers,

On June 15, 2001, the utility filed a request pursuant to Section 366.093, Florida Statutes (F.S.), that selected portions of the audit working papers prepared by staff receive confidential classification. The utility's request included redacted copies for public inspection (Document 07493-01) and highlighted copies (document 07494-01).

Documents 07733-01 and 07494-01 are currently held by the Division of Commission Clerk and Administrative Services as confidential pending resolution of FPU's request for confidential classification.

Pursuant to Section 119.07, F.S., documents submitted to this Commission are public records. The only exceptions to this law are specific statutory exemptions and exemptions granted by governmental agencies pursuant to the specific items of a statutory provision. Subsection 366.093(3)(d) provides the following exemptions:

“Proprietary confidential business information means information, regardless of form or characteristics, which is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to the ratepayers or the person’s or company’s business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public. Proprietary confidential business information includes but is not limited to:....

(d) Information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods and services on favorable terms.....”

According to Section 366.093, F.S., and Rule 25-22.006, FAC, the utility has the burden of demonstrating that materials qualify for confidential classification. According to rule 25-22.006, FAC, the utility must meet this burden by demonstrating that the information is proprietary confidential business information, the disclosure of which will cause the utility, the provider of the information or the ratepayer harm.

Staff Analysis of the Request

Reading the filing reveals FPU’s request applies to the following sensitive materials:

- 1) Material related to summary analysis of Gas Purchased for the Months of May and November 2000.
- 2) Detailed vendor invoices describing FPU gas purchases.

Staff Analysis (continued)

3) Information concerning off system sales (OSS) including analytical summaries, customer invoices, average price, calculated profit margins and profit, and reservation charges.

According to the utility, gas supply invoices provide a variety of information which could be used by those knowledgeable in the industry to identify the supplier of that purchased gas. Sensitive information includes the name of the gas supplier, the supplier's account number for FPU, invoice numbers, invoice dates, payment due dates, contract terms, applicable contract periods, volumes, unit prices, price computation methods and subtotal calculations, invoice amounts, payment instructions, descriptions of services provided, pipelines providing services to include upstream pipelines used, amount of gas provided by receipt point or meter, and vendor representatives and their telephone numbers.

For suppliers other than Florida Gas Transmission Company, FPU asserts negotiated gas purchases by Gate Station from suppliers, names of FPU's gas suppliers and total paid to these gas suppliers should receive confidential classification. FPU argues that if the information were released, competitors could use this operating information to fix prices which would ultimately lead to increased gas prices paid by the ratepayer. In addition, FPU claims releasing contractual terms and conditions could provide competing gas suppliers with an advantage over FPU and suppliers may be less likely to grant price concessions.

FPU also states it is contractually obligated to keep confidential material terms of its gas supply agreements and transactions. An agreement not to reveal information does not automatically guarantee that the information will be granted a confidential classification by the Commission. Material must otherwise met the requirements set out by Florida Statute – for example: release of the information must cause harm to the provider of that information and the material must not otherwise be disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public.

Duration of the Confidential Classification Period

FPU requests confidential classification of at least 18 months to negotiate future gas purchase contracts on favorable terms. Impacting this request, the utility further reports work papers 41-3/9, 43-2, 43-2/6, 43-2/7, and 43-2/8 involving November 2000 operations have already been granted protection until November 25, 2002, in another case. In addition, FPU reports work papers 41-3/4, 43-1, 43-1/7, 43-1/8, 43-1/9, and 43-1/10, involving May 2000 operations, are pending confidential classification from a previous FPU request. In the following staff recommendation, we have taken these factors into consideration.

Staff Recommendation

Based upon reading the filing, and for the reasons presented above, we recommend the utility's request be granted and that work papers 41-3/9, 43-2, 43-2/6, 43-2/7, and 43-2/8 be granted confidential protection until November 25, 2001, and the remaining material be granted a confidential classification for 18 months.





I tried to contact this gentlemen. Either i had the wrong number or he is not known. In any event, I decided to try anyone and ended up with "customer service. I spoke to a young women, whose name I have lost. She told me that notice had to go out before the PUC would consider any application. She gave me the internet site to review the docket and promised someone would get back to me. I downloaded the In re: Purchased gas adjustment Docket No. 070003-GU, Order No. PSC-00-2383-FOF-GU. Indded this order dated December 12, 2000 did authorize the charge but there is nothing showing the any notice. Also it was contrary to what MS Martin of the FPU had stated - " the PUC granted the company authority on November 1. 2000. by the way she also sent me an article from the Palm Beach post dated January 20th, where FPU was asking for another increase. Interestingly, no notice of this application for a "regular rate increase was given to FPU customers.

I use gas to heat a pool for my wife medical condition. Had I known that my ususal charge of \$125.00 was going to in crease by four hundred percent, obviously I would have not used it. I have paid the company under protest. Now, can I get PUC to do something on this improper method of this company.

I would appreciate some advice, even an aknowledgement. I have never received a return call.

I began serving as a consultant to Gas Research Institute (now Gas Technology Institute) soon after I completed my term as a Commissioner on the North Carolina Utilities Commission in 1997. You may recall that Tina Thomas, Ron Snedic and I met with you in early 1999 while you were with NUI Corporation.


As you may remember, GRI funding through a FERC imposed surcharge is being eliminated under the terms of a settlement agreement. GRI has sought permission from the various state commissions to allow continued funding at the 1999 level even as the surcharge decreases. A number of states have authorized voluntary contributions by the LDCs for the difference.

After our meeting with you and the other AGDF representatives, permission for some of the LDCs to make voluntary contributions to GRI and recover them from their PGA was secured "administratively" and such contributions have been received. However, I have been advised that Wayne Makin has notified Marc Schneidermann at Florida Public Utilities Company that such voluntary contributions can not be recovered through the PGA and that an adjustment must be made.

We would like very much to arrange a meeting with the appropriate Florida Commissioners and Staff to investigate possible ways in which the voluntary contributions could be continued. These contributions constitute a significant source of funding for essential core research in the natural gas industry.

Thank you for your consideration. I look forward to hearing from you at your convenience.
