For tracking purposes, it would be helpful if we can find and track agreements based on the ALEC and/or the incumbent LEC). In Docket No. 010794-TP (between Smart City and various KMC entities) all three ALECs are listed.

In addition to the above, we believe the Docket title should be amended to include each company name. My suggestion is:
