Kathleen, instead of sending several e-mails detailing problems with each docket I've reviewed this week, I'm sending this e-mail and will recap all of them.

In this docket, the letter is styled as an "adoption" to "adopt in its entirety" the underlying agreement, and any and all amendments. However, the Company is not adopting the agreement in its entirety because it is deleting and replacing several portions of Attachment 4. There appear to be four amendments being made as part of this adoption, but they are not shown in the BST letter.

This filing is also missing page 644 of 709, which is part of the Georgia Performance Metrics document and has a sheet number of 5-2.

Re-Connection Connection appears in the letter four times as "Re-Connect6ion Connection".

In the General Terms and Conditions, there are two different versions of the Page 19. The first version is dated 02/26/02, appears as sheet 23 of 82 and contains a listing of attachments [32.2] and options for purchase [32.3]. The second version is dated 06/3/02, appears as 23 of 81, and is the signature page. The PDF version of the online document shows this, but I cannot find it in the actual electronic documents BST filed. The electronic version of this page is not consistent with the two printed versions.

In addition to the above, the electronic version of the General Terms and Conditions is not the same as the hard copy filed. It appears this is just a shell document, and not the document you filed a hard-copy for. Additionally, it contains some different information.

Linda Dodson contacted you regarding this agreement and the error with the Company name (American Dial Tone with no Inc.)

This is missing page 44 of 469, which is part of Exhibit A and has a sheet number of Page 4. Page 400 of 469 appears twice. It appears that pages 458 of 469 through 469 of 469 are missing. Exhibit 1 begins with page 5 of 56 and appears to be missing pages 1 of 56 through 4 of 56. I'm concerned also because the pages are not numbered sequentially following the 469 pages.

In this docket (as in 020708-TP), the letter is styled as an "adoption" to "adopt in its entirety" the underlying agreement, and any and all amendments. However, the Company is not adopting the agreement in its entirety because it is deleting and replacing several portions of the underlying agreement. The Company is adding an amendment in addition to those of the underlying agreement, but does not indicate this in the letter.

This is missing page 805 of 854. This page appears in attachment 9, Performance Measurements, and has a page number of 6-2. I have found this page in the electronic copy of the document. CCA believes the Company needs to file this sheet with a memo indicating the correction.

Kay, I reviewed the hard copy of the above docket and like the PDF version, it is missing pages 596 of 729 through 599 of 729. The sheets appear as pages 5 through 8 of the Attachment 4 - Remote Site. The information IS in the electronic version of that attachment (Attachment 4 - Remote Site) but the page numbers don't match the printed or PDF versions.

The page numbers for almost all of the pages of this agreement are unreadable.

This is missing page 232 of 852 which is part of Attachment 2. It appears that several pages of this attachment are copied incorrectly, and is possibly missing more sheets. Please replace, in its entirety, ALL of Attachment 2.

Please make corrections, where necessary, for each of these agreements and submit them no later than October 9, 2002, or if necessary, letters to withdraw them.
