### CONSUMER COMMENTS

I attended your "informal" hearing in Lake Placid recently. I did not speak as I felt I needed to know more—primarily the Utilities' side of the story. I have since spoken with them. As much as I hate to see an increase in any of my expenses, I feel that the basis for their request is fair and justified and, therefore, I do *SUPPORT A RATE INCREASE.*

Water rates here in Florida seem to be universally higher than in the north. And, for those who are on wells there, may seem shocking. Be that as it may, it is a small price to pay for many other benefits we are privy to here in Florida.

I have also ascertained that the proposed rates are not out of line with those rates paid in other areas of Florida.

In addition, I would not want Placid Lakes Utilities to close its doors and be taken over by another entity. Its service is excellent and highly responsive. The quality of the water is above average. A take-over would, for a certainty, mean rate increased far in excess of those being requested, and, probably, poor service.

As to the gentleman who does not want to pay for services while he is "home" up north—that's too bad. A small price to pay for enjoying our warm weather! After all, the utility has to stay in business 12 months out of the year. He probably objects to his garbage charge, too!

As to the gentleman who considered it is right to wash his car and water his plants, etc.—where has he been? Obviously ignoring the water shortage restrictions and insensitive to the water shortage. I never considered it a "right" to have water available as we do today. I lived in Central America for a while and had to bring water to my house by bucket from a standpipe—and plan my water usage for the day or make additional trips. I have also lived in the north and had my well run dry.

As for the gentleman who was concerned about the rate being increase to cover the cost of new equipment, I wish he would/could sit down with the Utility staff and learn the restriction with which they have had to deal.


To the Florida Public Service Commission:

I am writing about the Petition for Limited Proceeding to Implement an Increase in Water rates by Placid Lakes Utilities. As I read it, the revenues (mostly from the water utilities bills of customers) are \$288,148 but operating expenses are a loss of 78,431. It doesn't seem to have much fiscal responsibility by going so beyond the revenues that should have been estimated and budgeted. It seems the Utilities just goes ahead and purchases and installs various additions, whatever it wants, with the idea that the additional expenses will just be "passed on" to the water utilities customers by a "limited" increase. [I said "limited" in quotes because in my experience in the past this "limited" increase becomes a permanent increase.]

Furthermore I feel an increase of 22.90% rate to pay for this loss is too high. With a cost of living rate around 4-5% annually, a new rate this high is really hard for people like myself with a very limited fixed income from Social Security Disability Insurance. Why can't these net operating losses be spread over a longer time at a much lower % rate?

Thank you for giving me the chance to voice of my opinion and concern.
