Dear Chairman Jaber:

Over the past several years, Orlando Regional Healthcare has been in the process of implementing a "Metro Area" dialing plan to better serve our patients and the community at large. We initiated this plan by acquiring a carrier class PBX and Central Office to serve our locations across our multi-county footprint.

In order to implement the plan, we asked BellSouth to obtain for us two full exchanges in the 407 area code. When we requested the two blocks of 407 numbers, we were informed the 407 blocks were exhausted and the PSC was in the process of implementing a new 321 area code for Central Florida. Based on that, we acquired 321-841 and 321-843 to implement our "Metro Area" dialing plan. Our internal team then spent time, resources and expense to notify all parties that would need to know our new numbers in order to continue our healthcare mission. Additionally, we did a total change of all of our telephone numbers in a variety of telephone directories across multiple telephone companies.

Several months ago, my telecommunications staff concluded they would require one more 321 block to complete the integration, so we initiated the request. After several months, we were informed that because of a recent Commission ruling, no additional 321 blocks would be released because numerous 407 blocks were now available. When we were informed of this decision, we took steps to explain our situation and the hardship that it would have on our healthcare system. In spite of that appeal, we were informed that no relief could be granted.

The purpose of this letter is to verify that my understanding of this situation is correct; and if it is, find out what additional steps are necessary to appeal to the Florida Public Service Commission to allocate 321-844 so we may finish our "Metro Area" dialing plan.
