The purpose of this letter is to request acknowledgment from the Florida Public Service Commission of an intra corporate reorganization whereby the Time Warner Entertainment-Advance/Newhouse Partnership (hereinafter "TWEAN") has formed TWEAN Subsidiary LLC as a wholly-owned subsidiary of TWEAN that will, among other things, oversee the operations of the certificated entity, Time Warner Cable Information Services (Florida) LLC d/b/a Time Warner Cable Information Services d/b/a Time Warner Cable d/b/a Time Warner Communications (hereinafter "TWCIS (FL) LLC").


