AMENDMENT ONE
TO THE
MASTER INTERCONNECTION AND RESALE AGREEMENT
FOR THE STATE OF FLORIDA

This Amendment One between Burno Inc. dba Citywide Tel, a Florida CLEC (“CLEC”) and Sprint - Florida, Incorporated, a Florida corporation (“Sprint”), herein collectively, "the Parties," is entered into and effective this 20th day of November 2002, for the State of Florida.

WHEREAS, the Parties previously entered into a Master Interconnection and Resale Agreement with an effective date of October 4, 2002 (“Agreement”) and;

WHEREAS, the Agreement adopts the terms of the Master Interconnection and Resale Agreement for the State of Florida entered into by and between Sprint and 1-800-RECONEX, Inc., dated June 30, 2001 ("Adopted Agreement");

NOW THEREFORE, the Parties mutually agree that the Agreement is supplemented and amended in the following respects:

3. RATES: Section 3 of the Agreement is amended to include:

3.2 The following products and services listed in Table 1A shall be available to CLEC at the rates indicated. Table 1A shall be considered incorporated into “Table One” of the Adopted Agreement.


