On Dec. 17, 2002, the Commission addressed Motions for Reconsideration in this proceeding. As part of its consideration, the Commission heard oral argument on an issue on its motion. On Dec. 30, 2002, Verizon filed a Motion for Reconsideration of Commission Vote for Procedural Impropriety asking the Commission to reconsider its vote, because it believes that the Commission should not have heard oral argument without further additional notice to the parties. Staff believes that it would be beneficial for the Commission to address this Motion as expeditiously as possible, particularly in light of the fact that the Order was rendered on Jan. 8, 2003, resolving the Motions for Reconsideration addressed by the Commission on Dec. 17. As such, staff believes it would be beneficial to have this issue addressed before an appeal is taken. While some responses to the Motion have been received, others continue to arrive, since the actual time for the filing responses hasn't run. Thus, staff asks for an extension to file this recommendation by 10:30 a.m., Fri., 1/10/03.
