There is an appeal pending in this docket. As such, and pursuant to F.S. 25-22.006(6)(d) documents which were not entered into the record and for which a claim of confidentiality was made, shall maintain their confidentiality and be returned to the parties no later than 30 days after the decision on appeal.

Pursuant to F.S. 25-22.006(8)(b), if a document was entered into the record and no timely request for confidential classification was made, then that document no longer maintains its confidential status.

Where there was a NOI filed and no timely follow up request, that document also loses its confidential status.

Where the document was filed after the hearing under claim, and not followed up with a timely formal request, there again the document no longer maintains its confidential status.
