24 On December 19, 2002, the Final Fee Application by Folger Levin & Kahn LLP, Special
25 Litigation Counsel for Trustee for the Chapter 7 Estates of NorthPoint Communications Group,
26 Inc. and NorthPoint Communications, Inc. (the "Trustee"), for the period from June 12, 2001
27 through October 31, 2002 came on for hearing at 10:30 a.m. before the Honorable Thomas E.
28 Carlson, Bankruptcy Judge of the Northern District of California, San Francisco Division.

1 Having considered the Final Fee Application, other submitted materials and arguments, and good
2 cause appearing therefor, it is hereby ORDERED:

3 1. Folger Levin & Kahn LLP's fees of \$4,017,017.00 incurred during the period from
