
**PETITION OF VERIZON FLORIDA INC. FOR APPROVAL OF

Verizon Florida Inc. (Verizon) (formerly GTE Florida Incorporated) files this petition before the Florida Public Service Commission (Commission) seeking approval of Amendment No. 1 to the interconnection, unbundling and resale agreement with Time Warner Telecom (Time Warner). In support of this petition, Verizon states:

The Verizon/Time Warner interconnection, unbundling and resale agreement was approved by the Commission on September 27, 2000 in Docket No. 000836-TP. The attached amendment adopts the reciprocal compensation plan put forth in the Order on Remand and Report and Order, *In the Matter of Implementation of the Local Competition Provisions in the Telecommunications Act of 1996, Intercarrier Compensation for ISP Bound Traffic*, FCC 01-131, CC Docket Nos. 96-98 and 99-68.

AMENDMENT NO. 1

to the

INTERCONNECTION AGREEMENT

between

VERIZON FLORIDA INC., f/k/a GTE FLORIDA INCORPORATED

and

TIME WARNER TELECOM OF FLORIDA, L.P.

This Amendment (the "Amendment") to the Interconnection Agreement between Verizon Florida Inc., f/k/a GTE Florida Incorporated ("Verizon") and Time Warner Telecom of Florida, L.P. ("TWTC") (the "Agreement"), for the state of Florida, is effective June 14, 2001.

1. Notwithstanding any possible contrary construction of this Agreement, ISP-bound traffic shall not be eligible for payment of reciprocal compensation under this Agreement. The Parties' rights and obligations with respect to any intercarrier compensation that may be due in connection with their exchange of ISP-bound traffic shall be governed by the Order on Remand and Report and Order, *In the Matter of Implementation of the Local Competition Provisions in the Telecommunications Act of 1996, Intercarrier Compensation for ISP Bound Traffic*, FCC 01-131, CC Docket Nos. 96-98 and 99-68 (the "Order on Remand").


