RE: Request for Permission from Comptroller's Office to Write Off the RAFs for the years

2001 and 2002 for Sphera Optical Networks N.A., Inc. d/b/a Sphera Networks (TX515)

On June 27, 2002, Docket No. 020604-TX was established to address Sphera Optical Networks N.A., Inc. d/b/a Sphera Networks' (Sphera) request for cancellation of its Alternative Local Exchange (ALEC) Telecommunications certificate due to Chapter 11 bankruptcy. By Order No. PSC-02-1339-PAA-TX, issued October 2, 2002, the Commission approved the cancellation of Sphera's ALEC Certificate No. 7681. The Commission further ordered that the outstanding Regulatory Assessment Fees not be sent to the Comptroller's Office for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write off the uncollectible amount.

Therefore, staff requests that the Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Department of Financial Services (formerly the Comptroller's Office) to write off the uncollectible RAFs, including penalty and interest, for the years 2001 and 2002 for Sphera.
