NOW comes Sprint Communications Company Limited Partnership (“Sprint”) and Verizon-Florida, Inc. (Verizon), who jointly ask this Commission for an eight (8) day extension of time, or until February 14, 2003, in which to execute and file an interconnection agreement. Pursuant to Order No. PSC-03-0048-FOF-TP, the parties are required to file a final executed agreement with the Commission on February 6, 2003. The parties need additional time to negotiate the final agreement.
