AMENDATORY ORDER

BY THE COMMISSION:

On December 19, 2002, we issued Order No. PSC-02-1788-PAA-TC imposing penalties and requiring payment of delinquent regulatory assessment fees, and requiring information in accordance with Rule 25-24.520, Florida Administrative Code, or ordering cancellation of Pay Telephone Certificate No. 7977 of Live Wire Systems, Inc. This order was made effective and final by Consummating Order No. PSC-03-0079-CO-TC, issued January 10, 2003. However, due to a scrivener's error, Order No. PSC-02-1788-PAA-TC stated that if the penalty and Regulatory Assessment Fees, including statutory penalty and interest charges, and required information were not received within 14 days of the issuance of the Consummating Order, the certificate should be cancelled effective on the date of the Consummating Order. The Order should have reflected that the effective date for cancellation of the certificate would instead be December 31, 2002. Therefore, Order No. PSC-02-1788-PAA-TC is amended to reflect that the effective date for cancellation of the certificate was December 31, 2002. Order No. PSC-02-1788-PAA-TC and Consummating Order No. PSC-03-0079-CO-TC are reaffirmed in all other respects.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-02-1788-PAA-TC is hereby amended to reflect that the effective date for cancellation of the certificate was December 31, 2002. It is further
