Hi Adam:

We granted Adelpia a bankruptcy cancellation effective 07/31/02 on its IXC and ALEC certificates and wrote-off the RAFs. The docket is closed. Today, we received the 2002 RAF form on the ALEC certificate (nothing for the IXC) and payment of the 2002 RAF minimum (\$50 -- no penalty and interest).

Ruth Nettles in CCA contacted me and asked if we need to notify someone or do anything since we've requested that the amount be written-off yet received payment. This is the first time this has happened to my knowledge, so I do not know the answer. Please let me know. Thanks.
