## AMENDMENT TO THE AGREEMENT BETWEEN ONEPOINT COMMUNICATIONS-GEORGIA, LLC D/B/A VERIZON AVENUE AND BELLSOUTH TELECOMMUNICATIONS, INC. DATED MAY 6, 2001

Pursuant to this Amendment, (the "Amendment") OnePoint Communications—Georgia, LLC d/b/a Verizon Avenue ("OnePoint") and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred to collectively as the "Parties", hereby agree to amend that certain Interconnection Agreement between the Parties dated May 6, 2001 ("Agreement").

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, OnePoint and BellSouth hereby covenant and agree as follows:

- 1. The Parties agree to delete Attachment 1, Section 5 in its entirety in the interconnection agreement dated May 6, 2001 for the state of Florida and replace it with the following:
  - "Notwithstanding the foregoing, BellSouth will provide OnePoint notice via Internet posting of price changes and changes to the terms and conditions of services available for resale per Commissions Orders. Where there is a generic Commission order to provide advance notice, BellSouth will comply. BellSouth will also post changes to business processes and polices, notices of new service offerings, and changes to service offerings not requiring an amendment to this Agreement, notices required to be posted to BellSouth's website, and any other information of general applicability to CLECs."
- 2. All other provisions of the Interconnection Agreement, dated May 6, 2001, shall remain in full force and effect.
- 3. Either or both of the Parties are authorized to submit this Amendment to the appropriate state Commissions for approval subject to section 252(e) of the Federal Telecommunications Act of 1996.

4. IN WITNESS WHEREOF, the Parties hereto have caused this Amendment to be executed by their respective duly authorized representatives on the date indicated below.
