COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Request for Specified Confidential Classification.

1. On February 19, 2003, BellSouth filed an Errata Sheet to W. Bernard Shell's Direct Testimony filed on October 23, 2003 and Revised Exhibit WBS-1. The information contained in Revised Exhibit WBS-1 reflects BellSouth's cost to provide certain services and the information is proprietary, confidential business information that is proprietary to BellSouth. BellSouth filed a Notice of Intent to Request Specified Confidential Classification on that same day.

2. BellSouth hereby withdraws the Notice of Intent to Request Specified Confidential Classification for the Errata Sheet to W. Bernard Shell. The Errata Sheet does not contain any proprietary confidential information.

5. Attachment B to BellSouth's Request for Confidential Classification is a redacted copy of the confidential information.

6. Attachment C to BellSouth's Request for Confidential Classification is a proprietary copy of the confidential information.

7. The information discussed in this Request for Specified Confidential Classification is valuable, BellSouth strives to keep it secret, and this information has not been generally disclosed.

8. The original of this Request was filed today with the Division of the Commission Clerk and Administrative Services and a copy was served on the Parties.

WHEREFORE, based on the foregoing, BellSouth respectfully requests that, pursuant to Chapter 364, Florida Statutes, the Commission enter an order declaring the information described above to be confidential, proprietary business information that is not subject to public disclosure.

Explanation of Proprietary Information
