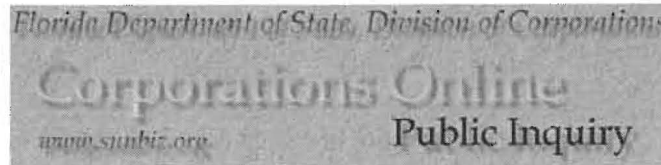
Kay,
