**AMENDMENT
TO THE
AGREEMENT BETWEEN
ACCESS INTEGRATED NETWORKS, INC.
AND
BELLSOUTH TELECOMMUNICATIONS, INC.
DATED FEBRUARY 17, 2000**

Pursuant to this Amendment, (the "Amendment"), ACCESS INTEGRATED NETWORKS, Inc. ("ACCESS INTEGRATED"), and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated February 17, 2000 ("Agreement").

WHEREAS, BellSouth and ACCESS INTEGRATED entered into the Agreement on February 17, 2000, and;

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The Parties agree that all terms, conditions, rates and provisions of the Agreement, dated February 17, 2000, shall remain in full force and effect for an additional period of three (3) months until May 17, 2003.
2. All of the other provisions of the Agreement, dated February 17, 2000, shall remain in full force and effect.
3. Either or both of the Parties is authorized to submit this Amendment to the respective state regulatory authorities for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
