CASE BACKGROUND

At the March 4, 2003, Agenda Conference, the Commission granted a pay telephone certificate to Holiday Travel Park Co-Op, Inc.. Prior to issuance of the Order from that vote, the Commission received a cancellation request from the company. Therefore, the Order from the Commission's March 4, 2003, vote in this Docket was not issued as scheduled. Instead, staff now brings this recommendation for the Commission's consideration regarding reconsideration of its March 4, 2003, decision in light of the company's requested cancellation.

DISCUSSION OF ISSUES

ISSUE 1: Should the Commission reconsider its vote at the March 4, 2003, Agenda Conference to grant Holiday Travel Park Co-Op, Inc. a pay telephone certificate and close the docket?

RECOMMENDATION: Yes. The Commission should reconsider its vote, because the underlying request upon which the Commission acted is now moot, and close this Docket upon issuance of an Order resulting from this recommendation. (MCKAY, KEATING, HAWKINS)

STAFF ANALYSIS: As stated in the Case Background, prior to issuance of the Order, the Commission received a request for cancellation from the Holiday Travel Park Co-Op, Inc.. In view of this request, staff recommends that the Commission reconsider its decision made at the March 4, 2003, Agenda Conference to grant the company a certificate, because the original application for a certificate has now been rendered moot by the subsequent request for cancellation. Because no further action by the Commission is necessary, staff also recommends that this Docket be closed upon issuance of an Order from this recommendation.
