Dear Ms. Bayo:

C III Communications, LLC ("C III"), C III Communications Operations, LLC ("C III Ops") Broadwing Communications Services Inc. ("Broadwing-CSI"), and Broadwing Telecommunications Inc. ("Broadwing-TI") (collectively, the "Parties"), hereby notify the Florida Public Service Commission ("Commission") about the transfer to C III Ops of the broadband business of Broadwing-CSI, including the assets and customers of Broadwing-TI.¹ Concurrently with the filing of this letter, C III Ops is filing with the Commission an Application for approval to transfer Broadwing-CSI's existing certificate. The Parties also request waiver, to the extent necessary, of the Commission's antislamming rules set forth in Chapter 25-4.18 with respect to customers transferred to C III Ops. A complete description of the transaction is included below.

I. The Parties

C III is a privately held Delaware limited liability company. C III is the parent company of C III Ops. C III does not currently hold any authority to provide telecommunications services. Upon closing of the proposed transaction, C III would be renamed Broadwing, LLC. C III Ops is a Delaware limited liability company that is wholly owned by C III. C III Ops would be the licensed service provider and enter into contracts with customers for the provision of services. C III Ops does not currently hold any authority to provide telecommunications services. Accordingly, as a condition precedent to the closing of the proposed transaction, C III Ops is seeking authority, where
