NOTICE OF ENTRY OF ORDER CONFIRMING PLAN OF LIQUIDATION DATED NOVEMBER 2, 2001

TO ALL CREDITORS, EQUITY SECURITY HOLDERS, AND OTHER PARTIES IN INTEREST OF ESSENTIAL.COM, INC. (THE "DEBTOR"):
