Re: Docket No. 010795-TP; Letter Notification of Withdrawal of Disputed Issue

Dear Ms. Bayó:

On February 28, 2003, Sprint Communications Company Limited Partnership (Sprint) filed a Motion to Resolve Disputed Language in this docket. Issue II identified in the Motion requested the Commission to determine the effective date of Verizon's UNE rates, adopted by the Commission in Order No. PSC-02-1574-FOF-TP, issued on November 15, 2002 in Docket No. 990649B.

At its April 9, 2003 Special Agenda Conference, the Commission granted Verizon's Motion for a Stay of Order No. PSC-02-1574-FOF-TP pending the outcome of Verizon's appeal of the Order to the Florida Supreme Court. The Commission's ruling resolves the issue of the effective date of Verizon's UNE rates. Based on the Commission's ruling, Sprint considers that this issue, as identified Sprint's Motion for Resolution of Disputed Language, is now moot and, therefore, withdraws this issue.


