ORDER ACKNOWLEDGING NAME CHANGE

BY THE COMMISSION:

By letter dated March 12, 2003, Murger Inc. d/b/a Lake Bonnet Village, holder of certificate to provide Pay Telephone (PATS) services, Certificate of Public Convenience and Necessity No. 7735, requested that Certificate No. 7735 be amended to reflect the new corporate name, Lake Bonnet Village Cooperative, Inc. Upon review of the Department of State, Division of Corporations' records, it appears that Murger Inc. d/b/a Lake Bonnet Village has properly registered the new corporate name. Accordingly, we find it appropriate to amend Certificate No. 7735 to reflect the new corporate name.

This Order will serve as the amended certificate to provide Pay Telephone (PATS) services, Certificate of Public Convenience and Necessity No. 7735 for Lake Bonnet Village Cooperative, Inc. Lake Bonnet Village Cooperative, Inc. should retain this Order as evidence of the name change. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by Murger Inc. d/b/a Lake Bonnet Village to change the name on Certificate No. 7735 from Murger Inc. d/b/a Lake Bonnet Village to Lake Bonnet Village Cooperative, Inc. is hereby approved. It is further

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of the Commission Clerk and Administrative Services and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
