The Department has completed its review of the O&S Water Company, Inc.. application to the Florida Public Service Commission for an expansion of its water service area in Osceola County. A copy of staff's memorandum is attached for your review.

The applicant will serve the proposed development through a Bulk Water Service Agreement with the Florida Governmental Utility Authority and has stated there will be no material impact on monthly rates due to the proposed increase in service area.
