Response: There will be no transfer of facilities as there are no electric services within the proposed boundary changes.

2. Will the end-use facilities of all existing customers of either utility be located wholly within their designated service area upon Commission approval of the addendum to the territorial agreement?


Response: All customers will be located wholly within the designated service area upon Commission approval of the Addendum to the Territorial Agreement. At the present time, a corner of the new Orange County Convention Center (OCCC) that is within the service territory of Progress Energy is served, at the permission of Progress Energy, by OUC. This Addendum to the Territorial Agreement will place this corner of the OCCC within the OUC service territory. The proposed territory modifications will also allow the Hyatt Hotel, located next to the OCCC, to be built within one service territory. The construction of this hotel is on hold at this time.

2. Please list the accounts of all existing customers that will be transferred due to the proposed retail territorial boundaries modifications in each of the five areas proposed for modification. Include in your response a copy of the customer notification letter, the number of customers objecting to the transfer, the concerns expressed by the objecting customers, and the method used to transfer customer deposits.


