

In support hereof, the Company states:

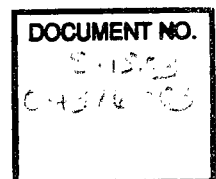
1) The Company is a natural gas utility company within the jurisdiction of this Commission. Its principal business address is:

3) Pursuant to the requirements of this Docket, the Company has revised prefiled testimony and revised purchased gas cost recovery true-up forms (Composite Exhibit CM-1) supplied by the Commission Staff in a manner consistent with the Commission Staff's instructions.



4) As indicated in the revised prefiled testimony and true-up forms, the Company had an actual underrecovery of \$760,869 for January, 2002 through December, 2002 as compared to an adjusted estimated underrecovery of \$1,234,930 for an overrecovery of \$474,061.

WHEREFORE, the Company respectfully requests that this Commission enter its order approving the Company's true-up amount for the period January, 2002 through December, 2002.


