

I, Kenneth A. Schifman, being first duly sworn, do hereby depose and state as follows:


1. I am an attorney with Sprint.

I declare that the foregoing is true and correct based on my knowledge, information and belief.

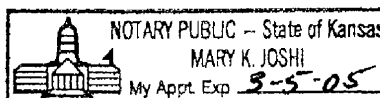


