ORDER CANCELING PAY TELEPHONE CERTIFICATE

BY THE COMMISSION:

ETS Payphones, Inc. (ETS), holder of Pay Telephone Certificate (PATS) of Public Convenience and Necessity No. 7433, has requested the cancellation of PATS Certificate No. 7433. ETS has complied with the provision of Rule 25-24.514(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its PATS certificate and by submitting its Regulatory Assessment Fees (RAFs) for the year 2002. Accordingly, we find it appropriate to cancel PATS Certificate No. 7433, effective February 26, 2003. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAF of \$50 if the certificate was active during any portion of the calendar year. ETS has provided in writing its intent to pay the 2003 RAFs by June 6, 2003, date certain. In the event the 2003 RAFs are not received from ETS by the date certain, a RAFs Return notice for the year 2003 will be mailed to ETS for payment by January 30, 2003. Neither the cancellation of its certificate nor the failure to receive RAFs Return notice for the year 2003 shall relieve ETS from its obligation to pay RAFs for the year 2003.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that ETS Payphones, Inc.'s Certificate No. 7433 to provide Pay Telephone services is hereby canceled, effective February 26, 2003. It is further

ORDERED that ETS Payphones, Inc. shall remit Regulatory Assessment Fees for the year 2003 by June 6, 2003. It is further



Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of the Commission Clerk and Administrative Services and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
