

Dear Ms. Merchant:

Pursuant to our prior commitment, I am providing to you and all other parties in this proceeding our second status report of activities concerning the transfer of the water and sewer plants from Zellwood Station Cooperative to Orange County for the month of May. The following activities have occurred:

- (1) On May 1, 2003, representatives of the Board of County Commissioners of Orange County informed Zellwood of a slight delay in processing the agreement. The purpose of the delay was to enable Orange County to determine whether it would transfer the three agreements to the City of Apopka.
- (2) On May 5, 2003, Zellwood was successful in convincing the County to proceed forward with the agreements regardless of any negotiations between Orange County and the City of Apopka. An assignment by Orange County to the City of Apopka of its interest in the three agreements does not, at this time, appear likely. The County has committed to Zellwood that it will not assign the agreements without commitments from Apopka to provide in-city rates without annexing Zellwood Station, among other things.
- (3) Dealing with the Apopka issue resulted in a slight delay in the Section 125.3401 hearing from May 20, 2003 to June 3, 2003. The hearing will take place next Tuesday, June 3, 2003, at 3:30 PM.


