Dear Toni,

Enclosed find original and two copies of our Application for Authority to Provide IXC Service in the State of Florida along with our check of \$250 for the application fee.

Please note that many of the officers of Broadstar Communications are or have been affiliated with other companies holding or having filed for certificates from the PSC. Included in that list are Russell Bell, President, and Tyler and Douglas Bell, Directors of Travelers Telecom Corp, an entity no longer doing business.

When that company went defunct, we called the PSC to find out how to "unregister" TTC and was told by staff to do nothing and it would automatically 'go away'. I understand now that that was wrong.

So that such compliance matters will not be an issue in the future, in good faith the Officers in common between Travelers and Broadstar have implemented strategies to prevent any non-compliance. A person has been set in place who will be specifically in charge of compliance matters for Broadstar.

Additionally, in order to rectify this matter, we are enclosing checks covering fees, fines, penalties and interest as follows:


