AT&T Communications of the Southern States, LLC ("AT&T"), pursuant to Rule 28-106.204, Florida Administrative Code, hereby moves the Florida Public Service Commission for a modification of Order No. PSC-03-0635-PCO-TP to extend the time for filing direct and rebuttal testimony in this proceeding and in support states:

1. By Order No. PSC-03-0635-PCO-TP, the direct testimony and rebuttal testimony in this proceeding are scheduled to be filed June 11, 2003 and June 25, 2003, respectively. At the same time, the parties are engaged in settlement negotiations, which they anticipate will result in the amicable resolution for all matter at issue in this proceeding. These negotiations will require some additional time to achieve a successful conclusion.



In light of the efforts to reach a settlement, AT&T hereby requests that the Commission extend the time for filing direct testimony until June 18, 2003, and the time for filing rebuttal testimony until July 2, 2003. 
