

**MOTION FOR EXTENSION OF TIME**


COMES NOW ITC^DeltaCom Communications, Inc. d/b/a ITC^DeltaCom ("ITC^DeltaCom") through undersigned counsel and requests an extension of time to file rebuttal testimony in this docket. As grounds, ITC^DeltaCom would state:

1. On April 23, 2003, the Commission entered Order No. PSC-03-0534-PCO-TP establishing the procedure for this docket, including dates for filing testimony and other events.
2. The procedural order establishes June 18, 2003, as the date to file rebuttal testimony and ITC^DeltaCom would request that this be extended to June 25, 2003. The parties are continuing to work to resolve issues and they believe that the additional week will enable the parties to reduce the number of issues requiring rebuttal testimony and resolution by the Commission. This extension will, therefore, enable the Commission and parties to better focus their resources on the remaining issues. The remaining procedural dates set forth in Order PSC-03-0534-PCO-TP would remain unchanged.
3. The undersigned counsel has contacted counsel for BellSouth and counsel for BellSouth agrees with the request for extension. The extension would apply to all parties.

WHEREFORE, ITC^DeltaCom requests that the date for filing rebuttal testimony be extended to June 25, 2003, for all parties.
