AMENDATORY ORDER AND FIRST ORDER REVISING  
THE ORDER ESTABLISHING PROCEDURE

BY THE COMMISSION:

On June 12, 2003, we issued Order No. PSC-03-0703-PCO-TP establishing the procedure in this docket. However, due to scriveners' errors, the date of the Prehearing Conference was listed as February 4, 2004, and the date of MCImetro Access Transmission Services, LLC, and MCI WORLDCOM Communications, Inc.'s (MCI) Surrebuttal Testimony was omitted. The correct date of the Prehearing Conference is February 9, 2004, and MCI may file Surrebuttal Testimony on September 29, 2003. Therefore, Order No. PSC-03-0703-PCO-TP is amended to reflect that the Prehearing Conference will be held on February 9, 2004 and MCI may file Surrebuttal Testimony on September 29, 2003.

In addition, Order No. PSC-03-0703-PCO-TP stated that objections, or requests for clarification, of discovery were to be made within ten days of service of the recovery request. However, the parties requested in their joint Motion for Procedural and Scheduling Order that objections and responses to discovery would be provided simultaneously and served electronically and via US mail no later than 21 days after receipt of the request. Therefore, Order No. PSC-03-0703-PCO-TP, is amended to reflect that objections, or requests for clarification, of discovery shall be provided simultaneously and served electronically and via US mail no later than 21 days after receipt of the request.


Based on the foregoing, it is
