The purpose of this letter is to request validation by the Public Service Commission of the name change of the owner and operator of the above-referenced certificates. As you will see from the attached corporate documents filed with the Florida Department of State and the Delaware Department of Corporations, my client TWEAN Subsidiary, LLC, has changed its name to "Bright House Networks, LLC". In addition, the subsidiary operator of the certificates held by this entity, Time Warner Cable Information Services (Florida), LLC, has also changed its name to "Bright House Networks Information Services (Florida), LLC."
